<p>I understand that: 1) Any major defects to the vehicle (such as flat tires, deployed airbags, leaking fluids, damaged windshield, missing or damaged windows, malfunctioning brakes etc..) or the inability to stay running on its own, will result in refusal of its acceptance for transport by Oceanex; 2) All doors and hatches must open and close using their own mechanical locking device and that welding or strapping down of doors or hatches is not permitted; 3) Once the vehicle is delivered to Oceanex for shipment, I will not have any have access to it until it reaches its destination; 4) Oceanex does not provide fuel for vehicles being transported; 5) Oceanex is not liable for any damage, loss or theft of Goods claimed to be in the vehicle and that such Goods (whether owned by me or someone else) are moved at my risk as the Customer; 6) Used vehicles are accepted and shipped by Oceanex on an "as is, where is" basis and that no claim will be accepted by Oceanex for minor damages (dents, scratches etc.), unless it can be shown that the damages occurred while my vehicle was in the care and custody of Oceanex; 7) Oceanex reserves the right to inspect and search any vehicle entering on to its premises or marine vessels to ensure compliance to all applicable laws and regulations.</p>		<input type="checkbox"/> Yes <input type="checkbox"/> No
